COVID-19 (novel coronavirus) update

As a valued member of the Sundale community, I wanted to provide you with an update and outline Sundale’s current approach to managing the COVID-19 situation.

QUEENSLAND – CONTACT TRACING

Sundale Retirement Community residents who have been to any of the [listed](#) exposure venues in Queensland at the relevant times, must follow the health advice and contact Sundale Retirement Villages Manager, Leigh Kersnovske (0448 560 331 or leigh.kersnovske@sundale.org.au) immediately.

RECENT CLOSE CONTACTS – QUARANTINE AND WAIT UNTIL FURTHER ADVICE FROM QUEENSLAND HEALTH

If you have been to any of the below locations in Queensland at the relevant times you must:

- immediately travel by private transport directly to your home or accommodation and [quarantine](#);
- complete the online [contact tracing form](#) - *if you are unable to complete the contact tracing form, please call 134 COVID (134 268)*;
- continue to [quarantine](#) until you are contacted by Queensland Health, who will advise you when to get tested, and how long you need to quarantine for.

LOW RISK CONTACTS – MONITOR FOR SYMPTOMS

If you have been to any of the below locations at the relevant times you must do the following:

- monitor for [COVID-19 symptoms](#);
- If you experience any symptoms:
 - [quarantine](#) at your home or accommodation;
 - [get tested](#) and quarantine at home until you receive a negative result;
 - complete the online [contact tracing form](#) - *if you are unable to complete the contact tracing form, please call 134 COVID (134 268)*;

- continue to [quarantine](#) even after receiving a negative result. After you complete the contact tracing form you will be contacted by Queensland Health.

NEW SOUTH WALES

TRAVEL PASS - TRAFFIC LIGHT SYSTEM

From Saturday (19 June 2021), the Queensland Government made it compulsory for anyone entering Queensland to fill out an [online travel declaration](#), regardless of whether they have been to a COVID-19 hotspot.

All travellers entering Queensland from interstate or on a quarantine-free flight from New Zealand must comply with the new declaration process (including returning Queensland residents).

The online form takes approximately three minutes to complete, with a declaration issued immediately via email.

The travel declaration scheme will operate like a *traffic light* system.

A green pass means you have not visited a COVID-19 hotspot and can travel freely into Queensland.

If you have been to an interstate exposure site, you will be issued with an amber pass and required to follow particular quarantine conditions on arrival.

If you have been to a declared COVID-19 hotspot, you will be directed to fill out a second form to obtain a Queensland border declaration pass.

Declared hotspots are "red zones", meaning you will not be permitted to enter unless you are a Queensland resident or are coming for a limited range of essential purposes.

Returning Queenslanders must hotel quarantine at their own expense.

Sundale will continue to work with Queensland Health and make responsible, considered decisions to help minimise the threat of COVID-19 entering any Sundale facilities.
